## GRIDWORX PRODUCTS FIVE YEAR WARRANTY

Gridworx Lattice and 2'x4' decorative panels will not be affected by water, rot, mildew, insects, household chemicals or separation. Gridworx Lattice and 2'x4' decorative panels is made out of durable plastic with a solid color throughout. As with any exterior product, expect some fading of color overtime. Product will expand and contract with temperature changes.

If a defect in materials or workmanship appears in your Avon Plastics Gridworx Lattice or 2'x4' decorative panels within five years from the date of original purchase at retail, Avon Plastics will replace the defective product.

The warranty does not apply to: Damage caused by accident, abuse, mishandling or dropping, improper installation, "Acts of God", or units that have not been used in accordance with directions. We do not cover labor or consequential damages.
